I/We agree that any notice of cancellation or variation of this standing instruction which I/we may give to the Bank shall be given at least four Business Days prior to the date on which such cancellation/variation is to take effect.

 - 3) This Standing Instruction will be cancelled automatically on the day following the 'Expiry Date'. If you wish the Standing Instruction to have effect indefinitely (or until cancelled by you) please leave the box blank.
 - 4) Please ensure that you sign the form in accordance with the signing arrangements of your Bank Account.
